- October 10, 2018 San Diego County Board of Supervisors approved expanding CRQ into a FAA Modified Design Class C/D-III Airport and for those who understand "FAA Speak", indicated CRQ will become a 24/7 "Reliever Airport" for San Diego International Airport (SAN)!

On October 10, 2018 San Diego County (County) Board of Supervisors approved the expansion of McClellan-Palomar Airport (CRQ) into a Modified FAA Design Class C/D Airport. NOW in addition to that approval - on March 27, 2019, Carlsbad dropped its CEQA lawsuit against the County and signed an unbelievable one-sided Settlement Agreement (Agreement) with the County. This settlement seems to give the County and the FAA full control of CRQ airport property AND complete control of land around the airport. Furthermore Carlsbad seems not to be fully enforcing its powers granted by 1980 Ordinance 21.53.015 and the Conditional Use Permit (CUP) 172. These are the powers which San Diego

County agreed to comply with when Palomar Airport was annexated into Carlsbad on December 28, 1978.

What we also know is the world temperatures are raising and the Arctic, Antarctic and Greenland's ice melting at accelerated rates. This fact is already causing our coastal cities to flood and will cause more to spend trillions of dollars to protect their infrastructures.

In this coming world of destruction, San Diego County seems to be one of the worst deniers that Global Warming exists. For example:

- 1. Three times the State of California has ruled that the County's Climate action plan is inadequate.
- 2. Five times State (3) and Appeals (2) courts have ruled that the County's option to purchase foreign GHG credits for development project does not comply with AB32 requirements to reduce GHG emissions by 2020.
- 3. Since 2009, the county has been pushing to expand CRQ from a small recreational aircraft FAA Design Class B-II airport into the October 10, 2018 approved a FAA Design Class D-III airport capable of landing 737 and 757 aircraft.

What does Expanding CRQ mean for the surrounding communities within 10 a mile radius of the airport?

As Fred R. Barnard is quoted in March 1927, "A picture is worth ten thousand words;" or as Supervisor Bill Horn stated in the December 16, 2015 Board of Supervisors meeting "I, I think this is a big huge commercial driver here and I think we are planning an airport here for, if not 50 years, may 100." click the photos below to see just some of the misery the County knows will happen. The County is not talking about this misery, but is rather ignoring the facts that will be hitting our community as a result of the County's protecting the large business community. The County's constant activity against it resident's welfare is now leaving very little doubt regarding whom the County is protecting.
